APPROVED SCHEME OF SERVICE FOR PHARMACIST CONSULTANT CADRE IN THE OYO STATE CIVIL/PUBLIC SERVICE

I wish to inform you that after careful consideration of the position of the National Council on Establishments (NCE) at its 41st meeting held from Monday 4th – Friday 8th November, 2019 in Asaba, Delta State as captured in the circular letter No. HCSF/CSO/HRM/1274/T3 dated 11th September, 2020 issued by the Office of the Head of Service of the Federation, approval has been granted for the adoption of Pharmacist Consultant cadre for inclusion in the Schemes of Service in use in the Oyo State Civil/Public Service.

The cadre is structured on Salary GL.15 to GL.17 as follows:

	POSTS	SGL
(i)	Consultant Pharmacist -	SGL.15
(ii)	Consultant Pharmacist Special Grade II -	SGL.16
(iii)	Consultant Pharmacist Special Grade I -	SGL.17

3. The Scheme of Service for the cadre will be reflected in the new edition of the Schemes of Service to be published soon and subsequent Establishments Estimates while the method of entry and advancement within the cadre is as listed here under:

(i) Consultant Pharmacist, Grade Level 15

- (a) By advancement of a confirmed and suitable Chief Pharmacist who has passed the Part II Final Examination of the West Africa Post Graduate College of Pharmacists (WAPCP);
- (b) By direct appointment of a candidate possessing Part II Final Examination of the West Africa Post Graduate College of Pharmacists (WAPCP) or its equivalent and registered with the Pharmacists Council of Nigeria and must have practiced for at least seven years.

(ii) Consultant Special II Pharmacist, Grade Level 16

By promotion of a suitable Consultant Pharmacist who has spent at least four years on the grade;

(iii) Consultant Special I Pharmacist, Grade Level 17.

By promotion of a suitable Consultant Special II Pharmacist who has spent at least four years on the grade.

- 4. However, the Pharmacist Consultant cadre is for registered Pharmacists who have successfully graduated from the West African Post Graduate College of Pharmacists and certified as Consultant Pharmacist. This means that registered Pharmacists without this Postgraduate qualification are not eligible to move to the Pharmacist Consultant cadre but will continue to have their Career Progression based on the existing Scheme of Service for Pharmacist cadre structured on GL.10 to GL.17.
- 5. The effective date of this circular letter is 1st July, 2021.
- 6. Further enquiries arising from the interpretation of this circular letter should be referred to this Ministry for clarification.
