ELONGATION OF OFFICIAL REPORTER CADRE FROM GRADE LEVEL 08-17 AND GREATION OF ASSISTANT OFFICIAL REPORTER CADRE, GRADE LEVEL 07-14

I wish to inform you that the Oyo State Government has graciously approved the adoption of the Federal Government Circular No. HCSE/EPO/EIR/CND/S.100/25 of 8th October, 2012. The circular has elongated the Official Reporter Cadre from GL.08-17 and the creation of Assistant Official Reporter Cadre, GL.07-14. The entry qualification of Official Reporter Cadre shall be a relevant University Degree from a recognized University.
