## INCLUSION OF ANIMAL HEALTH AND HUSBANDRY TECHNOLOGIST CADRE IN THE SCHEME OF SERVICE


In furtherance to our earlier Circular Letter Ref. No. AD3.206/Vol.III/T/40 dated 21<sup>st</sup> June, 2021 on the above subject, I wish to inform you that after careful consideration, Her Honour, the Head of Service has graciously approved the review of the Animal Health and Husbandry Technologist Cadre. The Cadre is now structured on Salary grade Level 06 to Salary Grade Level 14 in the State Scheme of Service.

2. The structure of the Cadre is as follows:

POST	GRADE
i. Assistant Animal Health /Husbandry Technologist	06
ii. Assistant Animal Health /Husbandry Technologist III	07
iii. Assistant Animal Health /Husbandry Technologist II	08
iv. Assistant Animal Health /Husbandry Technologist I	09
v. Senior Animal Health /Husbandry Technologist	10
vi. Principal Animal Health /Husbandry Technologist	12
vii. Assistant Animal Health /Husbandry Technologist	13
viii. Chief Animal Health /Husbandry Technologist	14



3. Appointment into the Cadre shall be possession of Ordinary National Diploma (OND) on GL. 06 and/or Higher National Diploma (HND) on GL.08 In Animal Health/Husbandry Technology from a reputable and recognized Institution as applicable.
4. The Cadre shall be published in the next edition of the Schemes of Service.
5. This Circular takes Immediate effect and further clarification on its interpretation should be referred to the Ministry of Establishments and Training in writing, please.
