**IMPLEMENTATION OF OYO STATE AUDIT LAW 2021: ESTABLISHMENT OF AUDIT  
SERVICE COMMISSION.**

As part of efforts of the Oyo State Government towards ensuring proper accountability and transparency in governance and in accordance with the above law, the Executive Governor of Oyo State, His Excellency, Governor Seyi Makinde FNSE has graciously approved the establishments of the State Audit Service Commission (SASC) forthwith.

2. It is to be noted that the landmark successes recorded by the State in participating in the World-Bank Assisted State Fiscal, Transparency, Accountability and Sustainability (SFTAS) programme that had earned the State substantial benefits was due to the achievements in some Disbursements Link Indicators (DLIs) since the commencement of the Annual Performance Assessment (APA) in 2018.

3. As a result of this development and in accordance with the Oyo State Audit Law 2021, appointments to serve in the Board will be made by His Excellency, the Executive Governor. This is with a view to strengthening the State transparency, accountability, sustainability and fiscal management in order to ensure effective mobilization and utilization of financial resources for the benefit of the entire citizenry of the State.

4. All Staff of both Commissions are to continue to comply with the Civil Service Code, Extant Rules and Regulations, Terms and Conditions of Service within their respective Commissions.

5. In the circumstance, all Ministries, Departments and Agencies (MDAs) of the State Government, including Tertiary Institutions and Local Government Areas are to be guided by the development and work in accordance with the new structural arrangement in ensuring proper accountability and transparency.



6. Accordingly, all Accounting Officers of MDAs, Tertiary Institutions and Local Government Areas are requested to give the content of this circular wide publicity it deserves among their Staff.
